

## **“Mastercard® Card x FORTRESS Online Smartphone Flash Deal”**

### **Terms and Conditions**

This Promotion Offer is only applicable to a cardholder (“Cardholder”) holding a valid Mainland China, Hong Kong or Macau Mastercard card (“Eligible Mastercard”). An “Eligible Transaction” occurs when a Cardholder makes a transaction through FORTRESS’s online store on Web or Mobile App (“FORTRESS online store”) and uses his/her Eligible Mastercard card to pay for all relevant fares and fees associated with that transaction.
