

“Mastercard x Fortress Offer” Terms and Conditions

This Promotion Offer is only applicable to a cardholder (“Cardholder”) holding a valid Mastercard card (“Eligible Mastercard”). An “Eligible Transaction” occurs when a Cardholder makes a transaction through [Fortress eShop on Web or Mobile App \(“Fortress eShop”\)](#) and uses his/her Eligible Mastercard card to pay for all relevant fares and fees associated with that transaction.

- a. Promotion Period: 4 July, 2026 – 27 September, 2026 (time refers to Hong Kong time).
- b. Cardholders are required to make a single net transaction of HKD1,000 or above with the Eligible Mastercard at Fortress eShop and successfully select the “Mastercard x Fortress Offer” option under Promotion Offer to enjoy HKD50 instant discount. The instant discount will be applied automatically and shown on the Order Summary on the payment page on Fortress eShop.
- c. Cardholders are required to complete the payment with a valid Mastercard card to enjoy the offer.
- d. If cardholder settles part of the order amount by redeeming MoneyBack points or by eVoucher at Fortress eShop, the net transaction value refers to the order amount after deduction of the relevant amount, that is settled with Eligible Mastercard and it has to be of HKD1,000 or above to enjoy this offer.

- h. This promotion is not applicable to transactions made in Fortress’s physical stores and transactions made with mobile payment or e-wallet payment at Fortress eShop.
