

## **“Mastercard Fortress Chinese New Year Offer” Terms and Conditions**

This Promotion Offer is only applicable to a cardholder (“Cardholder”) holding a valid Mainland China, Hong Kong or Macau Mastercard card (“Eligible Mastercard”). An “Eligible Transaction” occurs when a Cardholder makes a transaction through Fortress online store on Web or Mobile App (“Fortress online store”) and uses his/her Eligible Mastercard card to pay for all relevant fares and fees associated with that transaction.

- a. Promotion Period: 5 January, 2026 – 24 February, 2026 (time refers to Hong Kong time).
- b. Cardholders are required to make a single net transaction of HKD1,500 or above with the Eligible Card at Fortress online store and successfully select the “Mastercard Fortress Chinese New Year Offer” option under Promotion Offer to enjoy HKD80 instant discount. The instant discount will be applied automatically and shown on the Order Summary on the payment page on Fortress online store.
- c. Cardholders are required to complete the payment with a valid Mainland China, Hong Kong or Macau Mastercard card to enjoy the offer.

If cardholder settles part of the order amount by redeeming MoneyBack points or by eVoucher at Fortress online store, the net transaction value refers to the order amount after deduction of the relevant amount, that is settled with Eligible Mastercard and it has to be of HKD1,500 or above to enjoy this offer.
